



## National Forest Recreation Association Annual Ranger of the Year Award

The National Forest Recreation Association (NFRA) originated its annual 'Ranger of the Year' Award in 1982. The award is conducted with the cooperation and approval of the U.S. Forest Service and Bureau of Land Management to generate nationwide recognition of outstanding professional and community service by federal recreation managers at the local level.

Candidates for 'Ranger of the Year' may be nominated by any private citizen using public lands for recreational purposes.

Final selection is made by NFRA's Board of Judges chaired by NFRA's President. The Award is based on the following:

1. Dedication to duties and cooperation with private parties and permit holders using America's public lands for recreational purposes.
2. Specific accomplishments relating to service to the public.
3. Participation in local community affairs.
